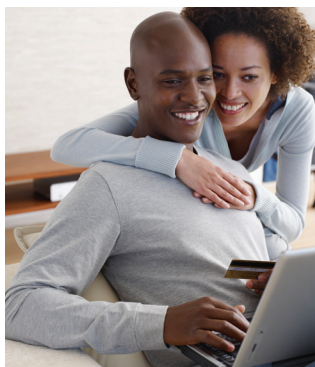

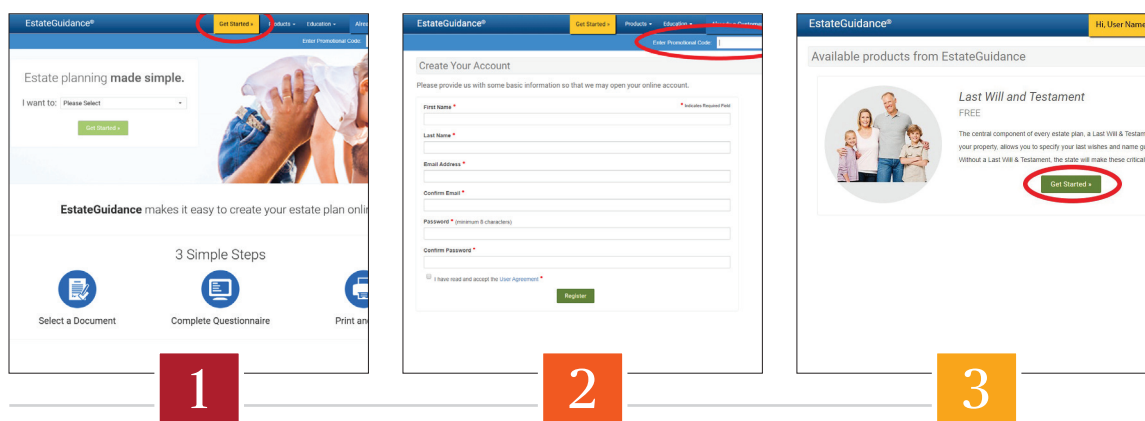
Online will preparation allows you to document your final wishes, such as
